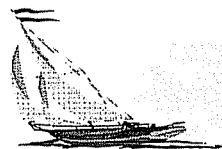

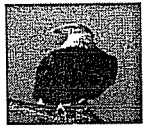

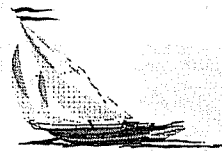

Browns Point/Dash Point Community Plan

Schedule before the Pierce County Planning Commission

The Pierce County Planning Commission will hold public hearings on the proposed Browns Point/Dash Point Community Plan and implementing regulations on Wednesday evenings in May. The hearings will be held at the Browns Point Improvement Club. The Planning Commission will hear staff presentation and public testimony on specific topics on certain dates as shown below. It is anticipated that action will be taken on May 21, 2008, at which time the Commission will make their recommendations. Public testimony will be taken only on the element presented at that meeting. **The public hearings will be held at: Browns Point Improvement Club, 7:00 pm**

The Planning Commission is expected to hear public testimony on the following subject areas on the following dates:

May 14 Land Use / Economic and Community Character Elements.
Associated Amendments to Pierce County Development Regulations:
Title 18A, Zoning; Title 18B, Signs; Title 18J Design Standards and Guidelines.

May 21 Facilities and Services and Natural Environment Elements.
Planning Commission discussion and final action anticipated.

NOTE: The Planning Commission is principally an advisory board to the Pierce County Council. Actions taken by the Planning Commission on almost all agenda items will be forwarded to the County Council as a recommendation for its consideration and final action.

Questions should be directed to the Planning staff at the Pierce County Public Services Building, 2401 So. 35th Street, Tacoma, WA 98409, or by calling 253-798-2785.

How to get information on what is being proposed. A brief staff presentation on the issue precedes most public hearings. Additionally, staff reports and proposed ordinances or resolutions are available in advance of the hearings. If you have questions, use part of your speaking time to ask the question and the Chair will ask staff to respond. Staff members are available before and after the hearing to answer questions or you may call them.

Written comment. Please send or submit your written comments to the Pierce County Planning Commission, 2401 So. 35th Street, Tacoma, WA 98409, or email comments to tfairba@co.pierce.wa.us. If you wish your comments to be distributed to the Commission in advance of a hearing, comments must be received by the Clerk of the Commission in the Planning Office a week before the hearing. If you want to deliver your written comments at the public hearing, please provide ten (10) copies to the Clerk of the Commission.

Sign in. Clearly PRINT your full name, address (ZIP included), and indicate if you wish to speak. People who sign in are called upon first. Please indicate if you are speaking as a representative of a group.
